

The US government has a vast library of information available online. The problem is that finding anything is not an easy job. There are so many different reports, tables, documents etc. some of it a bit repetitive, and unfortunately, some containing different mathematical results for the same information (such as number of arrests for rape or prostitution) making it difficult to know which statistic is the more accurate or current.

[If you find a statistic in one table or report that does not match another statistic that is posted here, you are welcome to share that with us, along with the location of the differing numbers.]

Perhaps because it is so difficult to find this information without a great deal of effort, journalists, politicians and others do not attempt to do any meaningful research which would expose the lies they are told by the prostitution abolitionists and victim pimp organizations. They no longer have an excuse. As an activist, you can point them to this material or send them directly to the government statistics.

### **DEFINITIONS:**

#### 'PROSTITUTION ABOLITIONIST VS. ANTI- TRAFFICKER'

No one wants to abolish human/sex trafficking more than sex workers. We do not want anyone to be forced into any type of labor, regardless of their age or financial situation. Unfortunately, there are many people who claim they are "anti- traffickers" but they are really anti-prostitution and their goal is to "abolish" or "eradicate" all commercial sex, including porn, stripping, exotic dancing, etc. How to tell the difference? If a group or organization supports and respects the rights of consenting adults to engage in commercial sex and they are willing to work with us to help fight all forms of human trafficking, then they are "anti- traffickers." If they claim that all commercial sex must be abolished to fight "sex trafficking," then they are prostitution abolitionists and care nothing about 'human trafficking.'

### 'SEX TRAFFICKING,' 'VICTIM PIMPS' AND 'RESCUE PIMPS':

There are many conflicting definitions for what constitutes "sex trafficking" and also many opinions of who is and isn't a "victim of sex trafficking" and who is a trafficker. It is so confusing for law enforcement agents that they have been known to arrest a "victim" and charge her with sex trafficking... of herself

Organizations which receive funding from the government and/or private donations have a vested interest in claiming that ALL SEX WORKERS ARE SEX TRAFFICKING VICTIMS, and the more victims they can con the public into believing are out there, the more money they receive from those 'pigeons.' For this reason, we call them "VICTIM PIMPS" or "RESCUE PIMPS" because they make their money off of sex workers (whom they allege are victims) and they 'rescue' us by having the cops kidnap us and then threaten us with incarceration if we do not accept their offer to be 'rehabilitated.'

•Government agencies categorize all minors (under 18) involved in any type of sex work as being victims of sex trafficking, regardless of their age or consent to engage in sex work, and even in states where the age of consent is 16.

Abolitionists (falsely) arque that because "the average age of entry into prostitution is 12 to 14" the majority of adult prostitutes must have become prostitutes as minors, and therefor their lack of ability to consent as minors carries over into their adulthood and they cannot be considered to have consented to engage in prostitution as adults.

As you will see in other sections of this document, the basis for the "average age" argument is a lie, because the study upon which their argument rests was a study of JUVENILE PROSTITUTES, AND NO ONE OVER 18 WAS INCLUDED IN THE RESEARCH. ("2001 COMMERCIAL SEXUAL EXPLOITATION OF CHILDREN IN THE US, CANADA AND MEXICO" PAGE 92 -93)

TO DELIBERATELY LEAVE OUT THE MOST PERTINENT INFORMATION ABOUT THIS 'STUDY' IS A LIE BY OMISSION.

For those over the age of consent, 'sex trafficking' is supposed to be defined as being coerced or tricked into prostitution against one's will, but prostitution abolitionists contend that all sex work is done against one's will. They claim that all prostitution is rape or like rape and that women cannot "consent to be raped." [AND YET <u>WHEN WE ARE RAPED BY LAW ENFORCEMENT OFFICERS</u>, IF THE COPS ARE ARRESTED AND IF THEY ARE PROSECUTED, THE ARGUMENT IS THAT WE MUST HAVE CONSENTED TO THE COERCED SEX ACT. PROSECUTORS DECLINE TO PURSUE CASES AGAINST RAPIST COPS, CONTENDING THAT IT MUST HAVE BEEN CONSENSUAL BECAUSE SHE WAS A PROSTITUTE....]

This is a convenient but illogical argument which denies the voices of the majority of sex workers who say they chose to engage in sex work for a variety of reasons, and that being "economically coerced" into sex work (another specious argument of the abolitionists) is no different than any other adult who is 'economically coerced" into any other job. NOT LIKING ONE'S WORK IS NOT A LEGITIMATE REASON TO EITHER BAN THAT TYPE OF WORK OR TO ARREST THOSE WHO ENGAGE IN SUCH LABOR!!!!

Put simply, "Rescue" means "arrest" - taken into custody.

#### 'RESCUE AND RESTORE'

Those who kidnap sex workers, using law enforcement agents to do their bidding, believe that the 'end justifies the means.' The cops— working with the 'faith based rescue' organizations- seize/ kidnap/ 'rescue' sex workers off the street as well as whose who find their clients on the internet, and drag those kidnap victims to the rescue organizations facility where they are threatened with arrest if they do not agree to enter the 're-education program' offered so kindly by the 'well meaning' Christians who only want to teach these poor beings that "Jesus loves them" and that they would be so much better off if they learned skills that could help them find acceptable employment earning minimum wagé and or going on the government dole. These nice folks want to 'restore' us bad women and return us to the 'state of grace' where women are supposed to be: virtuous, chaste, humble and good wives who obey their husbands and only have sex with them in the missionary position.

Those who do not accept the terms of confinement in the 're-education camp' are then arrested and sent for prosecution and subsequent incarceration in the city or state facility where they can be raped by the guards as punishment for daring to refuse the generous offer of the rescuers.

#### 'END THE DEMAND'

An insane policy which criminalizes the clients and employers of prostitutes (even though in most places where prostitution is illegal, criminalization already covers all those persons including the prostitute)—while decriminalizing the sex worker. If even a small percentage of the alleged number of JUVENILE prostitutes existed, the number of 'johns' hiring them would be so great that it would outnumber the entire adult male population of the US... see Part V- Fast Facts...

### 'SEX WORKERS' (all prostitutes are sex workers but not all sex workers are prostitutes)

Sex work includes all forms of financially compensated adult activity—legal or illegal (stripping, porn, phone sex, web cam sex, dominatrix, escorting, writing pornographic scripts, and of course, prostifution; there are other types of sex work as well).

#### 'PIMPS/ MADAMS/ HUMAN TRAFFICKERS'

The government/ law enforcement considers ANYONE to whom a sex worker gives ANY of the money earned through sex work to be a 'pimp' or 'madam.' This could be someone who facilitates the safety of the sex worker, or someone who arranges an encounter for a sex worker, or who drives a sex worker to their encounter. It is also applied to others who may have nothing to do with facilitating sex work—such as a family member: children, parents, spouse, boyfriend, girlfriend etc, as well as landlords, banking institutions, and ANYONE who may 'financially benefit' from the victims' sex work. All of those persons are now threatened with and arrested as 'human traffickers.' The cops also seize the money earned by a sex worker and use the funds to prosecute "the victim" and arrest more 'victims.

#### 'JOHNS' / UNIQUE NUMBER OF 'JOHNS'

Cops and prostitution abolitionists and the media refer to the men who pay us as 'johns.' Most of us refer to them as 'clients' or 'customers' because we view ourselves as professionals with a job providing sex care and intimacy.

A 'UNIQUE JOHN' describes someone who is a new client (to that sex worker) and not what we consider a 'regular client' who is someone who hires us more than one time and whom we may see on a regular basis for years.

### "OPERATION DO THE MATH" - WHAT THE FBI TABLES TELL US- AND WHAT THEY LEAVE OUT:

In addition to the tables and spreadsheets found in "Crime in the United States" (tables #1- #69), the Bureau of Justice publishes the "Criminal Victimization Report" (CVR) annually. This is a very informative document, which raises as many questions as it answers. In Part II- A & B , all of the classifications of crimes are listed and explained; crimes for which there is a 'complaining victim' (listed under "violent crimes" and "property crimes") and 'criminal activity' which the arresting officer(s) allegedly 'observed.'

Here are a few of the 'crimes' which are left out entirely from the FBI tables: (reported crimes and arrests), or which may be included under a different category of 'crime,' but we are given no explanation of what criteria is used to determine how or where these crimes are classified and documented, (yet clearly they are important and some are included in the CRIMINAL VICTIMIZATION REPORT- "CRV"):

# INCLUDED IN CVR- NOT INCLUDED AS SEPARATE CATEGORIES IN TABLES- AS REPORTED CRIMES OR ARRESTS VIOLENT CRIME AND SERIOUS VIOLENT CRIME: (see table 1 image above from page 2 of the 2015 CVR)

- ➡ domestic violence cases which were reported -& under what category are the reports noted?
- mediate domestic violence cases which were reported and resulted in an arrest
- reservous sexual assault which were reported (which were not classified as 'rape' because there was no vaginal penetration with a penis- according to the FBI crime definitions list)
- reservous sexual assault which were reported and resulted in an arrest (which were not classified as 'rape' because there was no vaginal penetration with a penis according to the FBI crime definitions list)

# NOT INCLUDED IN CVR- ALSO NOT INCLUDED AS SEPARATE CATEGORIES IN TABLES- AS REPORTED CRIMES OR ARRESTS FOR SEX CRIMES (NOT INCLUDING RAPE OR SERIOUS SEXUAL ASSAULT):

- ➡ Child sexual assault non commercial— which were reported or observed (where are the reported/ observed cases noted?)
- ➡ Child sexual assault non commercial- which were reported or observed and resulted in an arrest
- ➡ Child commercial sexual exploitation— which were reported or observed —no arrests made
- ► Child commercial sexual exploitation— which were reported or observed and resulted in an arrest of either a trafficker or a 'john,' or in the 'arrest/ rescue/ recovery' of the child

- ➡ Adult commercial sexual exploitation which is reported or observed in which the victim is not arrested or charged with a crime but a sex trafficker is arrested
- ► Sex traffickers- reported or observed- resulting in an arrest- under what category of arrest is this classified?

### HUMAN TRAFFICKING CRIMES (NOT INCLUDING SEX TRAFFICKING):

- Child labor exploitation reported or observed
- Child labor exploitation reported or observed which resulted in an arrest
- Adult labor exploitation reported or observed
- Adult labor exploitation reported or observed which resulted in an arrest
- ➡ All other adult and child exploitation/ trafficking reported or observed resulting in an arrest

It is rather important to know the source of the statistics used in the CVR, particularly when the numbers of specific 'reported crimes' for such criminal activity as 'rape' noted in the tables (#5) are fewer than the combined "rape and sexual assault" crimes listed in the CVR report... In 2015, there were 124,047 (see totals on last page of this spreadsheet)

REPORTED rapes... but only 19,304 arrests for rape (15.6% of arrests to reported rapes). The CVR for 2015 is not available as we update this section, so we do not know how many reported sexual assaults (not rapes) there were in 2015, and there is no report of how many sexual assaults resulted in an arrest.

No change was observed in the rate of serious violent crime from 2013 to 2014. There was no statistically significant change in the rate of serious violent crime—defined as rape or sexual assault, robbery, and aggravated assault—from 2013 (7.3 per 1,000).		to 2014 (7.7 per 1.000) (unble 1). The rate of simple assault declined from 15.8 victimizations per 1.000 persons in 2013 to 12.4 per 1.000 in 2014. Rates of total violent critical (down 29%) and simple assault (down 35%) were lower in 2014 than rates observed a decade earlier in 2005.

We do know that in the "Persons Arrested" summary from "Crime in the United States 2015" (click on image to go to page), the FBI claims "Nationwide, law enforcement made an estimated 10,797,088 arrests in 2015. Of these arrests, 505,681 were for violent crimes, and 1,463,213 were for property crimes..." even though table #69 (arrests by state-2015- see Part II-B), shows only 9,078,875 total arrests, of which 426,535 were for violent crimes and 1,248,583 were for property crimes (there were 1,968,894 reported crimes). (see PART II-B Crimes Total last page). According to tables # 5 and 69, that means the cops managed to solve 34.6% of reported violent crimes and 15.6% of reported property crimes, for an overall total of 18.2% of all reported crimes)

PLEASE BE AWARE THAT THERE ARE (MAJOR AND MINOR) DISCREPANCIES IN THE VARIOUS FBI TABLES AVAILABLE ON THEIR WEBSITE. WE HAVE DONE OUR BEST TO POST WHAT APPEAR TO BE THE MOST CURRENT NUMBERS FOR WHATEVER TABLES, SPREADSHEETS ETC. WE USED TO COMPILE THIS DOCUMENT.

# SUMMARY PART II A "OPERATION DO THE MATH"

### WHERE WILL WE FIND ENOUGH COPS TO ARREST ALL THE 'JOHNS'?

ACCORDING TO 2008 "CENSUS OF STATE AND LOCAL LAW ENFORCEMENT AGENCIES," (US DEPARTMENT OF JUSTICE REPORT) THERE WERE 765.246 STATE AND LOCAL LAW ENFORCEMENT AGENTS WITH THE AUTHORITY TO MAKE ARRESTS (SWORN OFFICERS). ACCORDING TO TABLE #77. THE STATE BY STATE NUMBER OF LAW ENFORCEMENT AGENTS in 2015 THERE WERE 631,517.

AS YOU WILL SEE IN THE SPREADSHEET IN THIS SECTION (SEE PAGE #10 TOTALS), THOSE OFFICERS MADE 9.078,875, ARRESTS IN 2015, BUT ONLY 18,45% OF THOSE ARRESTS WERE FOR CRIMES WHERE A VICTIM FILED A CRIMINAL REPORT, WHILE THE REMAINING ARRESTS (81.55%) WERE FOR 'CRIMINAL ACTIVITIES' OBSERVED BY A LAW ENFORCEMENT OFFICER; 'CRIMES' SUCH AS DISORDERLY CONDUCT, PROSTITUTION, GAMBLING, DRUG ABUSE, DRUNKENNESS, VIOLATION OF LIQUOR LAWS, ETC.

IN 2015, MILLIONS OF CRIME VICTIMS (9,225,197) ASKED FOR HELP BUT NO HELP WAS AVAILABLE FOR MOST OF THEM... WHY? BECAUSE COPS WERE TOO BUSY ARRESTING PROSTITUTES AND DRUG USERS TO LOOK FOR MURDERERS, RAPISTS AND BURGLARS... THE QUESTION IS, THEREFORE, WHICH OF THE VICTIMS WHO HAVE ASKED FOR HELP SHALL WE IGNORE IN ORDER TO 'RESCUE' ADULT WOMEN WHO HAVEN'T ASKED FOR HELP?



THE BEAUTY OF A SPREADSHEET PROGRAM SUCH AS MICROSOFT EXCEL AND APPLE'S "NUMBERS" (THE PROGRAM USED TO CREATE THIS DOCUMENT) IS BEING ABLE TO TAKE THE NUMBERS FROM THE TABLES AND PUT THOSE NUMBERS IN A CHART OR GRAPH. WHAT SEEMED TO BE A BORING SET OF NUMBERS (TO THE AVERAGE READER) SUDDENLY BECOMES A CLEAR PICTURE OF WHAT THE NUMBERS SHOW.

IN SUCH A FORMAT, IT EASY TO SEE HOW MANY OR FEW ARRESTS THERE WERE OF PERSONS FOR PROSTITUTION- AND THEIR AGES- FOR EACH STATE. SEPARATED FROM THE OTHER STATES IN THAT LONG AND BORING TABLE, EACH STATE CAN BE ANALYZED BY THE YEAR AND THE AGES OF THE ARRESTEES, AND ONE CAN INSTANTLY SEE WHETHER OR NOT THERE IS A DISCERNIBLE INCREASE IN 'SEX TRAFFICKING' - IF ARRESTS OF ALLEGED VICTIMS IS HOW THIS IS DETERMINED.

AS NOTED IN OTHER SECTIONS OF THIS DOCUMENT, WE DO NOT KNOW HOW THE GOVERNMENT CATEGORIZES 'VICTIMS' OF ANY HUMAN TRAFFICKING, OR HOW THE NUMBERS OF VICTIMS ARE CALCULATED. WE DON'T EVEN KNOW HOW MANY OF THE ARRESTS OF MALES, FOR EXAMPLE, WERE FOR BEING 'JOHNS' OR FOR BEING 'PROSTITUTES.' ALL ARRESTS OF MALES (AND FEMALES) ARE LUMPED TOGETHER IN ONE SET OF NUMBERS OF ARRESTS (FBI TABLE # 69).

FROM PART III- A, USING THE SPREADSHEETS, A GRAPH OF EACH STATE WAS CREATED TO SHOW THE PATTERN OF ARRESTS OVER 14 YEARS (2000 TO 2013). EACH TABLE BELOW THE GRAPH IS LINKED TO THE FBI TABLE # 69 FOR EACH YEAR. WE ENCOURAGE YOU TO GO TO THE FBI DOCUMENT AND VERIFY THE NUMBERS IN THIS DOCUMENT. WE CERTAINLY DO NOT EXPECT ANYONE TO TAKE OUR WORD FOR THE SPREADSHEETS, GRAPHS AND CHARTS WE COMPILED. IT IS JUST LAMENTABLE THAT THE 'VICTIM PIMP' ORGANIZATIONS AND THE PROSTITUTION ABOLITIONISTS WOULD BE AS THOUGHTFUL IN LINKING TO THEIR SOURCE DOCUMENTS SO THAT WE COULD LEARN WHERE THEY FOUND THE 'INFORMATION' THEY EAGERLY CITE ON THEIR WEBSITES.

WE HOPE THAT JOURNALISTS/ REPORTERS WILL USE THE LINKS WHEN THEY ARE WRITING THEIR ARTICLES, AND INVESTIGATE THE MANY, MANY DUBIOUS 'GUESSTIMATES' BEFORE SPREADING MORE FICTITIOUS STORIES ABOUT NON EXISTENT VICTIMS WHEN THERE ARE SO MANY REAL VICTIMS OUT THERE WHO WOULD LOVE TO HAVE THE MEDIA ATTENTION AND PERHAPS A SMIDGEN OF POLICE CONCERN THEIR SITUATION, SO THAT AN INVESTIGATION COULD BE CONDUCTED AND A PERPETRATOR FOUND AND PUNISHED.

THERE REALLY ARE NOT SUFFICIENT COPS, PROSECUTORS, COURTS, JAILS OR PRISONS TO HOLD ALL THE PROSTITUTES OR THEIR NON VIOLENT EMPLOYERS, CLIENTS AND ASSOCIATES- EVEN IF THE NUMBER OF PROSTITUTES AND CLIENTS IS NOT THE HUNDREDS OF THOUSANDS - OR EVEN MILLIONS - THAT THE GOVERNMENT, PROSTITUTION ABOLITIONISTS AND 'VICTIM PIMPS' CLAIM.

WHEN YOU HAVE ONLY A 18.2% RATE OF ARRESTS FOR REPORTED CRIMES TO NON REPORTED CRIMES, AND EACH COP CAN ONLY MAKE - ON AVERAGE- 14.38 ARRESTS PER YEAR, IT IS UNCONSCIONABLE TO INSIST THAT THE COPS, COURTS, JAILS AND PRISONS BE FILLED WITH PEOPLE AGAINST WHOM NO CRIMINAL COMPLAINT HAS BEEN FILED.

WHY NOT ALLOW THOSE WHO ARE VICTIMS OF SEX TRAFFICKING TO GO TO THE POLICE AND REPORT THE CRIME, JUST AS ALL OTHER VICTIMS OF ALL OTHER CRIMES (OTHER THAN HOMICIDE) ARE REQUIRED TO DO BEFORE THE POLICE WILL CONDUCT AN INVESTIGATION? WHEN SOMEONE IS THE VICTIM OF RAPE OR SEXUAL ASSAULT, THE POLICE DO NOT GO OUT AND RANDOMLY ARREST PERSONS WHO MAY BE RAPISTS, EVEN IF THE VICTIM REPORTS THE CRIME. BEFORE AN ARREST IS MADE, THEY MUST DETERMINE IF THE CRIME TOOK PLACE, IF THE VICTIM IS TELLING THE TRUTH AND IF THEY HAVE EVIDENCE TO CONVICT THE PREDATOR.

ARE THE PROSTITUTION ABOLITIONISTS AND 'VICTIM PIMPS' GOING TO ASSERT THAT BEING THE VICTIM OF RAPE OR SEXUAL ASSAULT, OR OF DOMESTIC VIOLENCE IS LESS PHYSICALLY OR PSYCHOLOGICALLY HARMFUL THAN 'SEX TRAFFICKING'? ESPECIALLY WHEN THE 'VICTIM' OF 'SEX TRAFFICKING' HAS NOT CLAIMED TO BE A VICTIM OF ANYTHING?

FOR THE "END THE DEMAND" CROWD; OVER THE PAST 25 YEARS, FROM 1991 TO 2015, COPS ARRESTED 8 PERSONS (ADULT, MINOR, MALE, FEMALE) FOR "PROSTITUTION AND COMMERCIAL VICE" OFFENSES... Oceanside CA- On June 19th and 20th, members of the Oceanside Police Department's Special Enforcement Section, in conjunction with the Federal Bureau of Investigation, participated in a antihuman trafficking operation titled "Operation Cross Country', SES arrested five people for prostitution and one person for pimping on Thursday, June 19th plus an additional five people were arrested for prostitution on Friday the 20th.

Operation Cross Country is part of the FBI's Innocence Lost National Initiative and was conducted with the assistance of more than 8,500 local, state, and federal law enforcement officers representing 414 separate agencies. To date, 47 Innocence Lost Task Forces and working groups have recovered more than 2,200 children from the streets. The investigations and subsequent 1,017 convictions of pimps, madams, and their associates who exploit children through prostitution have resulted in lengthy sentences—including multiple sentences of 25 years to life in prison—and the seizure of more than \$3 million in assets.

"Child prostitution remains a major threat to children across America." said Kevin Perkins, acting executive assistant director of the FBI's Criminal, Cyber, Response, and Services Branch, "It is a violent and deplorable crime, and we are working with our partners to disrupt and put behind bars individuals and members of criminal enterprises who would sexually exploit children."

The 2014 sting operation as reported in multiple news outlets- none of them seem to get any of the stats right- or at least the same stats. The average age of entry into prostitution in the U.S. is 12 years old, thus many of the over-18-year-old-females seen working in prostitution started in their youth (NCMEC, 2009). All child prostitution is sex trafficking. About 80% of the victims of human trafficking are women and children who are being sold into sex slavery (DHHS, 2006). Often the women and children enter into prostitution due to false job opportunities. Victims of sex trafficking can be found working in massage parlors, brothels, strip clubs, escort services, modeling studios, pornography, internet classified ads, truck stops, and walking the streets as prostitutes. In a study done on prostitution, 89% of women stated they wanted off the track (Farley, 2008).

Domestic minor sex trafficking is the most hidden form of child abuse in the

"This is what Modern-Day Sex Slavery In America Looks Like"

"People are not programmed to have sex with multiple strangers [a day]," says Lori Cohen, a senior staff attorney for the advocacy group <u>Sanctuary for Families</u>, adding that <u>trafficking victims sometimes must have sex with 60 men a day.</u> "In order for somebody to do that, their defenses are broken down."

It's bad enough that the <u>POLARIS PROJECT</u> claims that 'sex trafficking victims' have to have sex with between <u>25</u> and <u>48</u> men per day (<u>THE POLARIS PROJECT INFO ON "RESIDENTIAL BROTHELS"</u>)— and that there are <u>100,000</u> to <u>300,000</u> MINORS being trafficked into prostitution EVERY YEAR... but apparently that isn't sufficiently shocking to the average person, so now it is claimed that trafficking victims "sometimes" must have sex with 60 men per day... How many of trafficking victims would that be, Lori? 1? 10? 100? Perhaps ONE person was forced to have sex with 60 men on ONE daybut to sustain such impossible numbers on a regular basis is NOT possible. Lori's organization also works with victims of domestic violence—so perhaps she might also claim that victims of domestic violence are beaten by their (husband, boyfriend, partner) 60 times per day?

In the first part of this section- Fast Facts- we included a few tables with some statistics for the larger 'guesstimates' given by the Federal Government and 'victim pimp' organizations like the Polaris Project, of what the numbers would look like if the annual number of new underage victims was added to the number from previous years, if the average lifespan is 4 to 7 years and the average age of entry into prostitution is 13: 100,000 NEW added to 300,000 or 400,000 previous victims who haven't yet died as would be indicated by the information from the government and other sources. Laws.com - <a href="http://sex-crimes.laws.com/prostitution/child-prostitution">http://sex-crimes.laws.com/prostitution/child-prostitution</a> claims there are "300,000 to 600,000 [child prostitutes] in the United States of America..." Apparently many lawyers aren't good at doing math either...

Plus, we also did some tables with adults added and what the number of adults would have to be in proportion to the number of minors based on the 1.81% average number of female minors arrested to female adults arrested. But how about the smaller set of numbers without compounding the victims from previous years— what would those numbers look like? So we did more calculating with just minors — for a possible annual number of both minors and the 'unique johns' per day they might be forced to service, over 100 days per year, 200 days per year and 300 days per year.

And then there are the stats for the widely hyped "Superbowl Sex Trafficking" stats (guesstimated to be over 10,000 victims trafficked to the event every year- mostly minors, according to the news reports). We don't know how many men actually attend the Superbowl every year, whether or not they come alone or are with their wives or girlfriends, or other family members- or how long they are in town before and after the big day. So we used the following variables: 5 days, 7 days and 10 days. If there was any chance that there could be 10,000 sex trafficking victims flown in for the event, obviously the more men they serviced, the more profitable it would be, but then there are costs to take into account (like airfare and ground transportation, hotel and meals) and a few issues that need to be cleared up in order to make that number of sex slaves at the Superbowl viable:

- 1) How many 'sex slaves' can one pimp bring to the event and still control them?
- 2) How many rooms or suites will they need in a hotel? How many bedrooms should they book? Aren't hotel rooms in the surrounding area often booked months in advance by those attending the event? Where will the sex slaves stay if there is no room at the inn?
- 3) If there is more than one 'sex slave' per pimp, where will they all sleep?
- 4) How will they find their 'johns'? Who will answer the phones? Who will do the booking? Who will take the payments?
- 5) Where will all the 'johns' wait while other 'johns' are being serviced?
- 6) Wouldn't the hotel or motel notice if there were long lines in the hallway outside a room or suite? And what about room service? Them hos' gotta eat at some point...
- 7) What about housekeeping? Will the 'sex slaves' need more towels and washcloths than the average guest? What about changing the sheets? emptying the trash cans filled with used condoms and condom wrappers... won't they notice things like that?
- 8) The expenses of getting the sex slaves to the event, putting them up in hotels or motels, feeding them, having someone book appointments and keep the guys from getting impatient—these things cost money. There is no guarantee that there will be enough 'johns' to keep the 'sex slaves' busy, and of course, with all those cops looking for the sex slaves, it might not be a profitable event at all. Perhaps there aren't 10,000 sex slaves being trafficked to the Superbowl after all...

But we did some tables with those stats as well... you can see that the numbers are rather outrageous, if there were that many sex slaves and they had as many as "60" men a day to service.... variables are from 100 days worked per year to 300 days worked per year:

# "AT WHAT COST?"

FAST FACTS- USING MATH TO EXAMINE THE LIES OF THE 'VICTIM PIMPS,'
HOW MUCH DOES THIS CRUSADE CURRENTLY COST AND WHAT WILL IT COST IF COPS ARREST AS MANY 'JOHNS' AS THE
ABOLITIONISTS WANT THE COPS TO ARREST, PROSECUTE AND PUNISH (INCARCERATE)? WHO BENEFITS FROM THIS ABSURD
CRUSADE? FOLLOW THE MONEY AND THE PEOPLE PUSHING THEIR AGENDA...

Now comes the difficult part of doing the math'- calculating both the financial and non-monetary costs of this 'end the demand' crusade to all those whose lives will be negatively impacted by the insane desire to stop adults from wanting adult companionship and sexual intimacy even if it is for pay... (the math is only difficult for those who think that it is possible to 'end the demand' by arresting the men, women and couples who use the services of adults who work in the sex industry)... What costs will be incurred by society as a whole and individuals in particular if we 'amp' up the crusade against consenting adult commercial sex? A look back in history at the prohibition of alcohol and the current 'war on drugs' shows what other areas of life will be impacted by the moral and social busybodies who believe that they have some special right to impose their values on everyone else regardless of the cost. How many innocent people havé been collateral damage for the 'drug warriors' who go to the wrong house to execute a search warrant based on the dubious word of a 'confidential informant' - an individual who is allowed to continue to use/ sell drugs as long as he/ she continues to provide information on OTHER, NON INFORMANT folks who may or may not be guilty of the alleged crime?

We currently spend HUNDREDS of billions of dollars arresting, prosecuting and (usually) incarcerating over one million people a year [see part V-A page 5] for producing, selling, possessing and ingesting unapproved substances. Prisons and Jalls are overcrowded and often unsanitary, creating unhealthy conditions for people who will someday rejoin us in society. They will be filled with rage at the injustices inflicted on them because they were arbitrarily: selected to be arrested and punished for ingesting unapproved substances into their own bodies. Ironically they could have taken drugs (and probably DID) while incarcerated because the guards who were hired to watch over them frequently offer inmates more and better drugs than inmates could have purchased on the streets. It is much easier to control unruly inmates if they are not going through withdrawal. Unfortunately, the guards also ingest those same unapproved substances, usually without consequence.

The overcrowded conditions in prisons and jails have led to court cases which resulted in judicial rulings mandating the release of

many inmates early, including those whose crimes were violent. Now the prostitution abolitionists are demanding that we fill the prisons and jails with non violent, non abusive men against whom no criminal complaint was filed—other than by a law enforcement officer who no doubt entrapped the victim of the sting operation. If the crusade to 'end the demand' is to be 'successful' (which it will never be, as we know from countries like China, even though they execute 'pimps')—the demand has not diminished at all—and COPS in China, as in every other country where prostitution is illegal, 'protect' prostitution rings, in effect, becoming the 'pimps,' it would take the arrests of millions of 'johns,' including the very powerful and wealthy, the politicians, cops, judges, lawyers, preachers, priests, and all the other 'pillars of the community' who use the services of sex workers—before the average 'john' would get the message that he might be caught in the net, prosecuted and punished.

This poses several problems, as there are ONLY 631,517 state and local cops [see Part II A, page 10], many of whom are also 'johns' - and each cop can only make, on average, about 14.38 arrests per year? [see Part II A, page 10]... so, either we will have to hire a lot moreperhaps millions of cops- or we will have to stop enforcing all other laws and demand that the cops we currently employ work 24 hours a day, 7 days a week, no days off, no vacation, no don'ut breaks, nada. Even then, the likelihood of being able to apprehend more than a very small percentage of 'johns' is slim. How will cops decide which 'johns' to arrest and which to ignore? Perhaps the same way they now decide which sex workers to arrest and which ones to allow to continue to be 'exploited,' and that is by selectively enforcing the law against those "victims' who do not provide the nice officers with sex, money or information. The cops are not going to ask the 'johns' for those things, rather-they will offer to NOT arrest the 'johns' of the sex workers, if the sex worker provides them with sex, money or information.

ANY INTELLIGENT HUMAN BEING CAN SEE THAT THIS COSTLY MORAL AND SOCIAL CRUSADE IS NOT SUSTAINABLE. IT IS UNCONSTITUTIONAL AND IMMORAL TO IGNORE THOSE REAL VICTIMS WHO HAVE ASKED FOR HELP, WHO HAVE FILED A CRIMINAL COMPLAINT AND WHO WILL NEVER SEE JUSTICE. THE PRICE IS TOO HIGH. END THE CRUSADE.

### And finally, "OPERATION DO THE MATH"

Set aside for the moment that cops around the world use the laws (against prostitution) to rape, extort, threaten and pimp prostitutes—or the fact that there are SO VERY MANY cops who sexually exploit MINORS — or that adult men and women have a right to make choices for themselves ("MY BODY, MY CHOICE") and that in the thousands of years of attempted eradication of prostitution which include the execution of madams and prostitutes, prostitution continues to thrive—what do the prostitution abolitionists honestly believe the 'end the demand' crusade will do to stop people from doing what they want to do with other consenting adults?

Using their own 'guesstimates' of the number of alleged victims and their alleged 'johns'- which are mathematically impossible- we show that there is not a chance in hell to arrest enough 'johns' to 'end the demand.' There are not enough cops, enough courts, enough prisons, enough probation officers to compel the allegedly hundreds of millions of men (just in the US) to stop hiring a sex worker. And if you cannot stop LAW ENFORCEMENT AGENTS (or priests, preachers, teachers, rabbis, imams, doctors, neighbors or PARENTS) from sexually exploiting minors- and cops who sexually exploit prostitutes who are minors- how do they expect the cops to stop other men from doing the same?

How will the cops decide which reported crimes to ignore so that they can spend the requisite time pursuing and arresting millions of other men (besides themselves) who are hiring and having sex with prostitutes? Which violent crimes will go unsolved- such as the 5,704,712 reported violent rapes and sexual assaults (1991- 2015 Part V-A page 5) most of which were not even investigated and the victims of those violent crimes have gone without justice? And what about the victims of the 96% of all child sexual exploitation that is not committed by men who BUY the services of children- but is

committed by the pillars of the community as mentioned above? What will those victims think, knowing that those who claim to care about "the children"- DO NOT CARE ABOUT THEM AT ALL?

And how will the cops and the courts decide whom to arrest and whom to prosecute and punish? Will the men who are caught who are elected politicians (Eliot Spitzer, David Vitter, etc.) continue to 'skate' when it comes to their being arrested and charged with a crime? Will the cops only arrest those men whose sex workers refuse to provide the nice officer with a 'free sample'?

Because prostitution laws, like all other 'vice' laws, can only be enforced arbitrarily and selectively. And laws which allow HUMAN BEINGS- the cops, prosecutors and judges- to CHOOSE which 'violators' to arrest/ prosecute/ punish and which 'violators' to allow to continue to 'break the law' - for whatever reason- always have and always will engender corruption.

We know from many sources that there are ways to continue to 'violate' the laws with the blessing of the cops and courts.
