  Court documents show that four times county detectives allowed women at Moon Spa to perform sex acts on them once leaving a \$350 tip. A total of \$1,200 was spent during the visits...multiple visits were necessary so detectives could build trust with the operators.

The above law enforcement agents, politicians, judges etc. are but a few of the many who commit these crimes against prostitutes of all ages. Many of those who commit such crimes are never caught, and those who are caught are not always arrested, and if arrested, their case never gets media attention because such cases are thought to embarrass law enforcement etc. and are therefore kept private. Most who are caught, prosecuted and convicted receive very little time for their crimes.
