A Buffalo County jury found Williams guilty of six counts of sexually assaulting the girl between February 2001 and February 2003 while he was employed as a sergeant with the Ravenna Police Department. Williams hasn't been with the department since 2005.

It took the jury five hours to reach its decision in July. It was the third time Williams had been prosecuted.

His two previous trials in 2007 and in January each ended in a hung jury. Throughout his trials, Williams maintained his innocence.
