## [Officer Paul Brosky Molested Teen Girl \(pic\)](#)

Circuit Judge Barbara Areces on Tuesday sentenced a former Miami-Dade police officer to 50 years in prison with no chance of parole for the first 20 years for molesting a teenager he pulled over in 2002.

Paul Brosky, 40, was convicted in November of molesting the 17-year-old girl and kidnapping her during a traffic stop.

Areces included the 20-year minimum without parole -- actually two separate and consecutive sentences of 10 years -- because Brosky was armed with his service weapon when he fondled the teenager.

He is facing more molestation charges for allegedly fondling another teenager in a separate traffic stop. That case is set for trial in March. If convicted then, he could face life in prison.

Assistant State Attorney Bill Altfield offered Brosky a deal before Tuesday's sentencing: 25 years in prison in exchange for his agreement to resolve the other case and waive his right to appeal. The offer was an effort to spare the second teen the trauma of testifying, Altfield said.

"I made it clear that I was not offering that because of any weakness in my case," he said.

Brosky's attorney, Lindsay Glassman, said Brosky wasn't interested in the lighter sentence because he plans to appeal his conviction. "He has maintained his innocence since the beginning," she said.

Brosky's two teenage children testified at his sentencing hearing.

"They talked about how much they love their father and what a good dad he is," Glassman said.
