# Former Marysville police officer pleads no contest to charges of indecent contact with a minor

A former Marysville police officer pleaded no contest in Perry County Court yesterday to charges stemming from alleged inappropriate contact with a teen. **Robert Pavlovich Jr., 43, is already serving a minimum 10-year sentence for molesting or propositioning almost a dozen young women.**

The charges brought forth Wednesday included aggravated indecent assault, corruption of minors and unlawful contact with a minor.

The no-contest plea allows Pavlovich to accept the penalty of those charges without admitting guilt, according to Perry County District Attorney Charles Chenot. Typically, defendants plead no contest when it appears prosecutors have enough evidence to turn a conviction against them.

The charges stem from a preliminary hearing following Pavlovich's 2009 conviction, when his accuser testified that Pavlovich first made contact with her at a bus stop when she was 14 years old. She later said Pavlovich made inappropriate contact with her at least 30 times, often molesting her at her home.

With the no-contest plea, Pavlovich will serve no additional prison time.
