### **Now That's What I Call Affirmative "Action"**

Eric Tolen, a former affirmative action Federal prosecutor from the eastern district of Missouri, <u>is alleged to have a little too much "action" with two 15-year old teenage boys</u> in his Town and Country, Mo. home.

St. Louis County Circuit Attorney Bob McCullough alleges that Tolen allowed the two teens to reside at his house, and gave them material favors in exchange for sex. Tolen's lawyer told KSDK reporters that the charges are false, and stem from consensual relations that his client had with two 15-year old boys. Hey stupid, look up Missouri's statutory rape laws. Tolen was fired in 1999, for, among other things, and as quoted in the <u>legal documents filed in Tolen's lawsuit in 2004</u> against the U.S. Justice Department alleging improper dismissal based on racial discrimination:

Eric Tolen ("Tolen") was employed by the Department of Justice as an Assistant United States Attorney from 1987 until his termination in 1999. His termination followed allegations of, *inter alia*: perjury in connection with his brother's bank robbery trial, the unauthorized outside practice of law, making false statements to investigating officers, using government time, clerical assistance, and space for personal reasons, and misusing his position as an Assistant United States Attorney for personal gain. Pursuant to Department of Justice policy, Tolen was placed on administrative leave while the Executive Office for United States Attorneys ("EOUSA") completed an investigation into the allegations and ultimately recommended Tolen's dismissal.

This goes to show you how much of a rotten apple he was. He was hired in the U.S. Attorney's office by (supposedly anti-affirmative action) Ronald Reagan's U.S. Attorney for Eastern Missouri, and fired by Bill Clinton's.

<u>Tolen also represented former Overland Mayor "Raggedy" Ann Purzner</u> in her futile effort to save her job and to legitimize her illegal attempts to dismiss Overland City Attorney <u>Bob Herman</u>.
