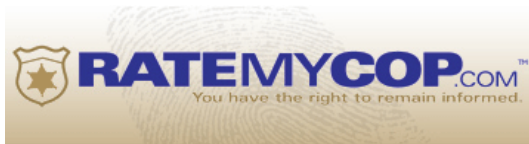

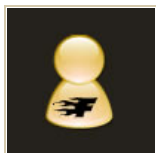

Former Fairfield County deputy pleads guilty to child endangering

Staff reports November 12, 2010

LANCASTER -- A former Ohio State University police officer and Fairfield County deputy pleaded guilty to child endangering as part of a plea bargain.

In June the Fairfield County Sheriff's Office SWAT team was called out to arrest Jason D. Henthorn, 35, in the 3900 block of Carroll-Eastern Road.

He was originally charged with gross sexual imposition involving a child younger than 13.

Henthorn pleaded guilty today to a first-degree misdemeanor count of child endangering.

Fairfield County Common Pleas Court Judge Chris Martin sentenced him to 180 days in the Fairfield County Jail with 59 days suspended in lieu of two years' good behavior, Assistant Fairfield County Prosecutor Gregg Marx said.

Henthorn was also ordered to have a sexual offender assessment completed and to comply with any requirements. He was additionally ordered not to have any unsupervised contact with minor females.

Henthorn had been working for the OSU police department from 2000 until his arrest. From 1996 to 2000, Henthorn was a deputy with the Fairfield County Sheriff's Office.

Former deputy convicted of child sex battery, faces 90 years

MILTON -- A former Santa Rosa County sheriff's deputy accused of child sexual battery was convicted Wednesday by a jury at the courthouse where he once served as head of security.

John Mitchell Tomlinson was found guilty of three counts of sexual battery by a custodial authority on a person over the age of 12 and under the age of 18, state attorney Bill Eddins said. The former sheriff's lieutenant faces 90 years in prison and a future trial on more sex crime charges.

"We feel that because of his position of trust in law enforcement and the ongoing nature over many years of this sexual misconduct, we're gonna ask the judge to impose the maximum penalty," Eddins said. "We do not believe he should ever walk the streets of the community as a free man again."

Tomlinson, 47, initially was charged with 120 counts of sexual battery by a custodial authority after the Sheriff's Office

asked the Florida Department of Law Enforcement to take over its investigation. He was placed on paid leave when he was arrested March 9 and fired May 7 after an internal investigation.

Santa Rosa County judges recused themselves from the case because of Tomlinson's former position at the courthouse, Eddins said. Walton County Circuit Judge Kelvin Wells presided.

The original charges stemmed from incidents involving three children, Eddins said. The state attorney's office consolidated the charges and narrowed down this week's trial to charges involving one of the children, but used testimony from the other two.

The prosecution presented a phone recording of a conversation between the victim and Tomlinson, who made "incriminating statements," Eddins said. He said lawmen are permitted to make such recordings without a warrant or court order if one of the two parties consents.

Tomlinson's recorded words supported the child's story, Eddins said. Tomlinson testified in his defense and denied the allegations.

The trial, which started Monday, concluded about 9:30 p.m. Wednesday after the jury deliberated three-and-a-half hours.

Tomlinson's sentencing is set for Dec. 14. A trial date for his other pending charges has not been set.

Former Sumter deputy sentenced on sex charges

SUMTER, SC (WIS) - A former Sumter County deputy will spend 12 years in prison for having sex with a 14-year-old girl in July 2009.

26-year-old Michael Boulware pleaded guilty November 8 to Criminal Sexual Conduct with a Minor, 2nd degree.

The incident happened near Wedgefield, which is located in Western Sumter County, sometime between June 1 and June 30, 2009.

Boulware, a former traffic patrolman with the Sumter County Sheriff's Office, was terminated in July after authorities charged him with three counts of contributing to the delinquency of a minor.

Investigators said Boulware bought alcohol for three 14-year-old girls; one victim is the daughter of a South Carolina Highway Patrolman.

The CSC charge was added after SLED began investigating the original allegations.

Boulware will be placed on the central registration of abuse and neglect.

Ex-internal affairs head suing Pa. state police

PITTSBURGH -- The former head of state police internal affairs in western Pennsylvania claims he was fired, rehired and put on restricted duty in retaliation for investigating whether a barracks commander wrongly interceded in a friend's child-molestation case.

Lt. Jeffrey Shaw contends state police brass persecuted him over relatively minor, and he says false, allegations that he received the complaint against the commander through improper channels. His lawsuit also argues that his bosses turned a blind eye to the commander's alleged misconduct.

The commander approached a trooper investigating the molestation allegations repeatedly to ask "how things were looking for 'our boy'" and told the trooper that if his businessman friend were arrested, the commander would "lose his golf privileges," the lawsuit said. According to the lawsuit, the commander "received free golfing privileges at a luxury golf facility owned by" the businessman friend.

The businessman's daughter also allegedly paid for an \$8,000 hunting trip for the commander in September 2008, when the molestation investigation was ongoing, according to the lawsuit. The commander also was friends with her husband, the businessman's son-in-law, the lawsuit alleges.

Spokeswoman Lt. Myra Taylor said state police defendants can't comment on the lawsuit.

The serpentine, 29-page lawsuit was filed Tuesday in Allegheny County and was first reported by the Herald-Standard in Uniontown. Shaw had headed the western Internal Affairs Division office, located in Harmar Township, in 2008, when the chain of events began.

The lawsuit refers to the commander Shaw investigated as "Lt. X" and the businessman as "John Doe," to protect the identify of the minor daughter he allegedly molested. The businessman was never charged.

According to the lawsuit, Shaw didn't learn of the allegations against the lieutenant, the since-retired commander of the Uniontown barracks, and his businessman friend directly. And it's because of that Shaw contends he was subsequently disciplined.

Fayette County Children and Youth Services called the Uniontown barracks in August 2008 to report the alleged molestation.

The trooper assigned to the case was transferred to the Belle Vernon barracks that fall but continued to investigate it. After being subjected to the commander's comments, the trooper told his new station commander, Lt. Richard Gardner, that he was "bothered" by the remarks, according to the lawsuit.

Gardner had also heard about the \$8,000 hunting trip and referred both concerns to a captain who failed to take any action against the Uniontown lieutenant, the lawsuit contends.

Gardner then shared his concerns with Sgt. Cheryl Amodei-Mascara, who sued the state police earlier this year for what she contends was an attempt to smear her reputation by suggesting she illegally interfered in the molestation investigation.

Shaw's lawsuit recaps Sgt. Amodei-Mascara's claims that she told her mother about the Uniontown commander's actions and that her mother called Shaw anonymously in December 2008, setting in motion Shaw's investigation. It would have violated state police regulations for the sergeant to have made an anonymous complaint against the lieutenant.

That's when two top internal affairs officials -- Major Charles Skurkis, commander of the state police Bureau of Integrity and Professional Standards, and Capt. Willard Oliphant, head of the bureau's Internal Affairs Division-- ordered an investigation into Amodei-Mascara. The findings of that probe were referred to Westmoreland County District Attorney John Peck, who declined to prosecute Amodei-Mascara or Shaw for allegedly interfering in the criminal molestation investigation.

Peck, in a letter to state police, said he determined that the Uniontown lieutenant "did receive a trip paid for by the daughter of a high profile person under investigation" and "did make remarks to an investigator that could be construed as inappropriate." Peck also determined some state police did receive golfing privileges from the businessman.

Peck declined to comment on Shaw's lawsuit, except to confirm for The Associated Press that his investigative findings were accurately recounted in it.

Shaw contends he was on restricted duty for much of 2009 and removed as IAD chief in western Pennsylvania. He was fired on May 26, 2010, but rehired and put back on restricted duty on June 9, before the grievance he filed over the firing could be heard.

**Ex-Navassa cop guilty of sex crimes
Leland man could serve 41 years for molesting two girls**

Jaymin Lenwood Murphy leveraged his position of authority -- first as a child's caretaker, and then as a Navassa police officer -- to coerce two underage girls into having sex with him.

In one case in January, Murphy, then a 35-year-old police officer, compelled a 14-year-old girl to have intercourse by telling her it was a component of a criminal investigation that law enforcement refers to as a "pressure test," according to the prosecutor.

On Monday, Murphy, now 36, stood in a Brunswick County courtroom wearing a baggy white and black striped jailhouse jumpsuit with his hands clasped behind his back as he pleaded guilty to one count each of statutory rape and statutory sex offense, two counts of sexual exploitation and four counts of indecent liberties with a minor.

Superior Court Judge Ola Lewis sentenced Murphy to a maximum of nearly 41 years in prison and ordered he undergo psychological evaluation and cover any medical bills related to his victims' injuries.

He will also undergo a lifetime of GPS monitoring by ankle bracelet and is barred from contacting anyone under 18 years old, though Lewis did carve out an exception allowing Murphy's two children to visit him.

As part of the plea arrangement, the judge agreed to dismiss three counts of rape and two counts of indecent liberties with a minor.

Assistant District Attorney Meredith Everhart, the leading prosecutor on Murphy's case, called the sentence "a good resolution for the victims and the whole community."

"This saved both victims from having to testify again him," Everhart said. "At the earliest, he'll be 67 years old before he is released, and I'm satisfied with that."

The StarNews does not name victims of sex crimes.

During the court hearing, an image of Murphy's sexual predation emerged as Everhart chronicled how he began

engaging in intercourse as early as 2005 with a then-girlfriend's 11-year-old daughter.

Murphy, while employed as a cab driver and living with his girlfriend, had sex with the pre-teen girl between 35 and 40 times until he moved out in 2007, Everhart said. Murphy was not a police officer at that time.

Murphy's first victim was reluctant to disclose the crimes until February 2010. After an investigation by the Brunswick County Sheriff's Office, Murphy, of 9586 Old Mill Road in Leland, was charged with first-degree rape of a child. He was arrested on Feb. 18, suspended from his job at the Navassa Police Department, and held in the county jail.

Amid the media attention surrounding his arrest, a second victim stepped forward, accusing Murphy of sexual exploitation and coercing her into having sex with him on her 14th birthday.

Between December 2009 and January 2010, Murphy, then a Navassa police officer, was assigned to investigate whether a relative's boyfriend had sent inappropriate pictures to the victim.

Murphy brought the victim into a bedroom and told her that investigators required photos of her to compare to the images sent to her cell phone. So Murphy had the victim remove her clothing so he could take pictures of her genitals and breasts.

Murphy returned on her birthday in January, when he told her that he needed to conduct a "pressure test" to determine if she had been sexually active. On his town-issued cell phone, which was later confiscated by sheriff's investigators, Murphy recorded himself having sex with the teenager.

With the victims' families present in the courtroom, Murphy did not offer an explanation for his actions, just answered the judge's questions with a solemn "yes ma'am" and "no ma'am."

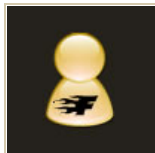

Former Minden officer pleads to juvenile cruelty charge

MINDEN -- A former Minden police officer facing rape and molestation charges pleaded guilty today to a lesser offense rather than go to trial.

Daniel Murray's plea to cruelty to juveniles came before jury selection was getting underway in Webster District Court. The charge carries a sentence of up to 10 years. Judge Bruce Bolin ordered a presentence investigation. No sentencing date was set.

"The victim obviously didn't want to testify," District Attorney Schuyler Marvin said. "We were satisfied with the plea especially because of that."

Murray was arrested in January 2009 after a 15-year-old teenage friend of the family accused him of rape. A Webster grand jury indicted him six months later, and he was subsequently fired by the Minden City Council. Murray has been incarcerated since his arrest.

He was the department's K-9 officer, and he had his dog with him at the time of the sexual assault in his apartment. The victim told authorities she feared being harmed if she resisted because she knew the dog was trained to protect his handler.

Ex-cop gets 10-year federal prison sentence for child porn

4:54 p.m. CST, December 9, 2010 SPRINGFIELD, Mo. -- A former Noel police officer and McDonald County reserve deputy received a 10-year federal prison sentence with no chance of parole on Thursday for sexually exploiting a child and for possessing child pornography. Casey Nanez, 28, of Noel, pleaded guilty last Sept. 2 to the charges in a federal indictment.

The McDonald County Sheriff's Department seized Nanez's computer in June 2009 during an investigation into allegations that he had unlawful sexual contact with one or more minors. During a forensic examination of the computer, investigators located several photographs of minors, including a set of photographs that depicted a minor engaged in sexual activity with an adult. Nanez admitted he took those photographs and downloaded them to his computer.

The McDonald County Sheriff's Department, the Joplin Police Department and the FBI investigated the case.

Former Lee sheriff's detective found guilty of sex crime charges

Joshua Payne, 27, was found guilty of lewd and lascivious molestation and two counts of lewd and lascivious conduct. All charges are second-degree felonies. The trial began Tuesday.

Payne was arrested in September 2009 after the Lee County Sheriff's Office received a tip about him contributing to the delinquency of a minor.

After an investigation at the victim's home, detectives learned Payne provided a young girl with alcohol and touched her under her clothing more than once at her home.

Investigators were also provided copies of text messages sent to the victim from Payne.

He had been with the agency since 2003.

Payne is now in custody at the Lee County Jail until sentencing.

Cop on trial for rape says that 'victim' is just a vengeful ingrate

Tyrone Wiggins, the former Philadelphia cop on trial for allegedly raping a girl over an eight-year period, yesterday denied the charge and insisted that all he ever was to the young woman was a mentor, godfather and karate instructor.

"I never touched [the victim] in any way," Wiggins, 51, said during the second and final day of testifying on his own behalf in Common Pleas Court.

Under questioning from his attorney, Scott P. Sigman, Wiggins sought to cast the victim - now a 25-year-old Philadelphia cop - as an ingrate bent on revenge.

Wiggins said the woman made up the rape story only when her application to become a police officer was put on hold in January 2006, after he told department officials that she had once sold drugs. The woman testified that she had never sold drugs.

Wiggins said he met the woman in 1995 when she was 10 years old and joined the karate class he taught at the Olney Recreation Center.

Wiggins said that he told her to stop selling cocaine and other drugs in 2003 and that he even made an audio tape of him lecturing her about the dangers of drug dealing.

When the woman decided to apply to the Police Department in 2005, he said, he served as a reference, but also told her to tell the truth about her past.

Wiggins said that after she told him that she had lied during her first meeting with recruitment officials in December 2005, he decided to give the officials the audio tape and a memo concerning the woman's alleged drug past.

In January 2006, Wiggins said, he met with a detective at the department's recruitment and background office and played the audio tape. The woman made her first threat to ruin him outside the office that day, he said.

"When [she] and I got outside, she got so upset and started crying," he recalled. "She said, 'You know I wanted to be a police officer. I wanted to be just like you.'"

"She said, 'You messed up my career and I'm going to mess up yours.'"

A week later, Wiggins said, an officer came to the home on Chew Avenue near Front Street that he shares with his wife

and four children to deliver a protection- from-abuse order filed by the woman.

"I fell apart because I had to give up my gun," said Wiggins, who remained on desk duty until August 2007. "Nothing like that had ever happened to me."

The protection-from-abuse order did not mention any allegations of rape or other sexual offenses, he told the jury.

After 23 years and eight months on the force, Wiggins resigned in November 2009 because, he said, he was about to be put back on desk duty because of the allegations. The next day, he was arrested and charged with rape, after a two-year Internal Affairs investigation.

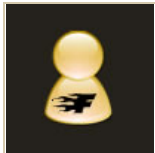

Police Officer Arrested For Child Pornography

A police officer has been arrested for owning and distributing child pornography. A 39-year-old Peyton man, Morgan Sellman, has been arrested for child pornography after an investigation by the Colorado Springs Police Department Internet Crimes Against Children Unit (ICAC).

On December 15, a search warrant was executed at Sellman's El Paso County home, while he was not present, and that's when it was discovered that Sellman was a sergeant with the Aurora Police Department.

Sellman was arrested Friday and booked into the El Paso County Criminal Justice Center and charged with 1 count of Sexual Exploitation of Children 18-6-403, a class 3 felony, for possession of child pornography. If convicted he could face up to 12 years in prison.

Investigators say at this point, there's no evidence that Sellman ever had any personal contact with a victim or used a city of Aurora computer to store images of child pornography.

Sellman has been placed on administrative leave without pay pending a disposition in the criminal case. Stay with 11 News and KKTU.com for more on this story.

Granby police officer arrested

A Granby police officer was fired and arrested on Wednesday, Dec. 15, charged with one class 3 felony count of exploitation of a child and two class 6 felony counts of exploitation of a child, according to Granby Police Chief Bill Housley.

The chief did not provide details about the extent of the 35-year-old officer's relations with the 16-18-year-old female Middle Park High School junior.

Housley said the Granby Police Department first learned of the suspected criminal conduct on Dec. 7.

The information instigated both an internal and criminal investigation at the department.

Sanchez was suspended from the department on Dec. 8 and was being held in the Grand County Jail in lieu of a \$20,000 bond. He bonded out late Thursday.

For the criminal investigation, the Granby Police Department sought assistance from the Colorado Bureau of Investigation, Housley said in statements released on Thursday.

Sanchez was arrested on Wednesday by Housley and Granby Police Sgt. Jim Kraker.

That same day, Sanchez was terminated from the force. An internal investigation concluded that Sanchez had violated Granby Police Department policies, Housley said.

Sanchez is married and the father of four school-aged children.

"We're disheartened and deeply disappointed and embarrassed that something like this could happen," Housley said. "As difficult as this is, I think we dealt with it efficiently and quickly and took disciplinary action that needed to be taken."

Former deputy guilty of incest

A former St. Tammany Parish Sheriff's deputy has been convicted on aggravated incest.

Late Friday night, a six-member jury found the Folsom man guilty after deliberating for more than three hours.

According to Rick Wood, spokesman for District Attorney Walter Reed, the man, who was an 18-year veteran of the Sheriff's Office criminal patrol division and a lieutenant, now faces up to 20 years behind bars.

His victim, whose relationship is being withheld along with the former deputy's name to protect her identity, was 17 at the time of the incident.

The former deputy invited the teenager to his home in Folsom in 2007 and then sexually abused her. She fled the home and went in search of a family member.

Wood said the victim was assisted by a "good samaritan" who helped her to locate the family member.

Once the sexual abuse was disclosed, the family member reported the incident to authorities.

The former deputy was arrested and fired the next day.

He was indicted on aggravated incest charges in 2008.

Wood said the incident is believed to be an isolated event, and it is not believed that the man abused any other teenagers.

Assistant District Attorney Leigh Anne Wall prosecuted the case for the state.

District Judge Allison Penzato is scheduled to sentence the former deputy on Feb. 14. The charge of aggravated incest carries a penalty of five to 20 years in jail.

An Albany, Ill., man, who serves on the town's volunteer fire department and is a correctional officer at the East Moline Correctional Center, is charged with aggravated child pornography.

Shawn A. Maze, 36, made his first appearance Friday in Whiteside County Circuit Court. He is being held in the Whiteside County Jail on \$250,000 bail.

He has been suspended from the Albany Volunteer Fire Department because of the charges, Fire Chief Leo Geerts said.

He remains an employee of the correctional center as the charge moves through the court process, a Department of Corrections spokeswoman said Friday.

Maze is accused of soliciting a girl under the age of 13 to photograph her exposed or partially exposed breast, according to court documents. The girl is not related to Maze.

Maze was arrested by the Whiteside County Sheriff's Department after a complaint was made to the agency by the girl's family, state's attorney Gary Spencer said.

If Maze posts bail, he faces several conditions, including not to consume alcohol, not to possess any firearms and to have any unsupervised contact with a child younger than 18.

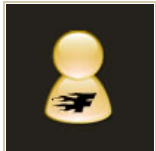

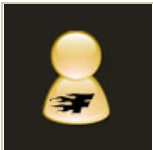

Two Maywood cops charged with official misconduct

December 21, 2010

A Maywood deputy chief who allegedly hit a man with his gun, then lied to police about the incident is just one of two officers charged with official misconduct in separate investigations.

Both men were arrested on Monday and are scheduled for bond hearings on Tuesday.

Deputy Chief Brian Black, 36, is charged with obstruction of justice and felony disorderly conduct in connection with an off-duty incident that happened in November in which he allegedly struck a man in the head with his service revolver, a release from the Cook County State's Attorney's office said. Black then lied to police and told them he was the victim of an attempted carjacking.

Black joined the Maywood Police Department in 1997 and was appointed deputy chief in June 2007, the release stated. He is accused of assaulting a victim whom he had been friends with for several months prior to the incident, the release stated.

They would often drive around together in Black's personal car while drinking alcohol and occasionally smoking marijuana, court records indicated.

Prosecutors allege that on Nov. 14, Black and the man were driving together on the West Side of Chicago when Black put his hand on the victim's leg in a "provocative manner" several times. The victim rebuffed his advances each time before punching Black and attempting to leave.

But just as the victim attempted to flee, Black took out his service weapon and struck the victim in the head with it as he fled. Both black and the victim called 911 but before police responded, Black hid his weapon in a nearby barbecue grill, according to the release.

Prosecutors said Black told responding Chicago police officers that he had been driving alone when the victim attempted to carjack him. During the investigation, however, Black gave several conflicting versions of events before investigators eventually learned the truth. Black also told officers where his weapon had been hidden.

Former Fox Lake Police Chief Patrick Lynch has been arrested and charged with sexual assault of a child and stalking.**

A former Fox Lake Police Chief is in jail tonight, charged with sexual assault of a seven year old girl and three counts of stalking.

Patrick Lynch retired in 2009 but all of these alleged offenses occurred either while he was still serving as police chief of Fox Lake or as a police officer in Randolph.

Lynch was the Chief in Fox Lake from 1996 to 2009. He's been accused of stalking, including threatening his ex-wife's boyfriend and a former employee of the Fox Lake Police Department, during that time.

But what really has people talking in this small town is another charge, sexual assault of a child under the age of 13.

Lynch was arrested this morning.

Fox Lake resident Daniel Dyer says, "I'm actually shocked because I heard good things about him but then again I heard bad things. I'm shocked."

Lynch's neighbor Tara Garlow says, "Very surprised considering I have kids that play in my back yard. I have friends that come over and sit in my back yard and they're always on their patio."

According to a criminal complaint **Lynch was serving as a police officer for the city of Randolph in 1989 when he fondled and raped a 7 year old girl, his friends daughter, in her bathroom.**

She says he was wearing his police uniform at the time.

The complaint alleges Lynch then stalked the girl for 19 years.

No one currently working in the Fox Lake Police Department would comment on the situation and the city administrator told us he has nothing to say.

Edica Feuerhammer has been Lynch's neighbor for more than 10 years

She says, "I was very surprised because in all the years I've lived there he has never shown me that he was in any way, that way."

Surprised by the allegations she says with 5 kids of her own she's never worried about Lynch.

She says, "I think that people should know him personally, or in a different way, before they start judging who he is."

Lynch is scheduled to make his first court appearance tomorrow.

MADISON, Wis. (AP) -- A former Wisconsin police chief is accused of sexually assaulting a 7-year-old girl more than 20 years ago.

Wisconsin Attorney General J.B. Van Hollen says former City of Fox Lake Police Chief Patrick Lynch was arrested Wednesday.

Lynch faces felony charges of sexual assault of a child and stalking.

According to the complaint, a 28-year-old woman says Lynch sexually assaulted her in 1989, when she was 7.

The woman also says Lynch later showed up at her workplaces and would drive his police car past her home.

Lynch also is accused of stalking a man who was dating his ex-wife and a woman who used to work for the Fox Lake Police Department.

Lynch is expected to appear in court Thursday. Court records do not list an attorney for him.

Ex-Arundel officer sentenced for porn

A former Anne Arundel County police lieutenant who had a sexual relationship with a 16-year-old girl was sentenced Tuesday to five years in prison, federal authorities said.

James Cifala, 47, of Edgewater, Md., was convicted of receiving child pornography. According to court papers, Cifala asked the girl to send him sexually explicit photos, and she complied.

According to court papers, Cifala and the girl met in 2007 and began exchanging text messages in 2009. He spoke to her about having sex, but told her they had to wait until she was 16-years-old. He also told the girl she had to earn his trust because he was concerned she would tell others about the relationship.

In 2009, when the girl was 16-years-old and Cifala was 46-years-old, the two had sex several times in his truck and a vacant house, according to a plea agreement in the case.

U.S. Attorney Rod J. Rosenstein said he hoped the case would "send a wake up call to parents about the need to monitor their children's use of cellular telephones and other communication devices."

Cifala had been with the Anne Arundel Police Department for 27 years prior to his arrest

An International Falls Customs Border Protection Officer was charged Thursday. He's accused of sexually assaulting a young girl multiple times over several years.

The Koochiching County Sheriff's Office arrested 45-year-old Patrick Hamburg on November 19th. In the criminal complaint, police said the Customs and Border Protection Officer admitted to the accusations, saying he felt terrible about what he had done.

According to the criminal complaint, Hamburg began sexually assaulting the girl in 2005. It extended over a four year period.

The report also stated Hamburg told the victim not to tell anyone or they would get in trouble.

Hamburg is now in custody and has been charged with three counts sexual assault in the first degree and one count of sexual assault in the second degree. Bail has been set at \$180,000.

U.S. Customs and Border Protection Public Information Officer Brian King said Hamburg worked as an officer for the International Falls Port of Entry for the past seven years. He said Hamburg had daily interaction with border crossers. Hamburg remains jailed in Koochiching County, but if he were released, the U.S. Customs and Border Protection Office said he would be reassigned to office duties.

Hamburg's court proceedings will likely move forward but at this point, there are no hearings scheduled.

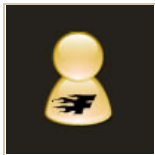

A woman who was sexually harassed by a Portland police officer in a series of explicit phone calls two years ago has filed a \$500,000 suit against the officer and the city of Portland.

The woman, who was 16 at the time, was one of a number of women who received sexually harassing phone calls from Officer Joseph Wild, who resigned after the allegations surfaced.

Wild pleaded guilty to repeatedly making sexually explicit phone calls on his police-issued cell phone to 10 females, including two police recruits and a 14-year-old relative, between November 2008 and April 2009.

During some calls, he threatened to rape the women or told them he wanted to see them naked, according to court documents. He was sentenced to six months in prison in December 2009.

In the suit filed Friday in Multnomah County Circuit Court, the woman says she was 16 and intoxicated when Wild gave her a ride in his patrol car to a juvenile facility. The woman, who is now 18, said **Wild learned personal information about her which he later used in a series of telephone calls to her home. Wild told her he had had intercourse with her while she was drunk**, prompting the woman to call police and file a rape report. A rape test was inconclusive, and the woman still does not know whether she was sexually assaulted by Wild.

The suit contends that the city was negligent in failing to do an adequate background check and to adequately supervise Wild.

The alleged abuse occurred while Perry was off duty, Winstead said, but he declined to release more details about the case.

Court documents show no force was used in the alleged incidents but that alcohol was involved.

Perry had worked for the department from April 2009 until November 2010, the chief said.

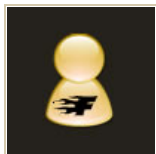

Ex-Chouteau County reserve deputy gets prison in sex assault

A former Chouteau County reserve deputy will serve four years in jail, with another 16 years suspended, after a judge sentenced him Tuesday for sexually assaulting a 10 year-old girl.

Cecil Allen Worsley, 51, of Fort Benton initially was charged with sexual intercourse without consent in Chouteau County and felony sexual assault in Cascade County. Both charges related to the same victim.

Cascade County dismissed its charge against Worsley earlier this month as part of a plea-bargain in the Chouteau County case.

District Judge Dan Boucher listened to nearly four hours of testimony Tuesday, hearing statements from the victim's family as well as from friends and family of Worsley, who spoke on his behalf.

Chouteau County Attorney Steve Gannon described the testimony of the victim's family as "gut-wrenching."

Gannon asked the judge to sentence Worsley to 30 years in jail, with 15 suspended. The maximum penalty for sexual assault is 100 years in prison.

Boucher sentenced Worsley to 20 years in prison with all but four suspended. The statutory minimum for the charge is four years in prison.

Worsley also was ordered to continue sex-offender therapy and will be required to register as a sex offender.

Worsley completed reserve-deputy training about a year and a half ago, and had since been activated to work along with another officer twice. He was ordered to turn in his uniform and badge when the allegations were made in August.

An Oklahoma City police officer who has three adopted children and three foster children has been arrested on complaints of lewd acts with a child younger than 16 and forcible sodomy.

Police spokesman Capt. Patrick Stewart said Sgt. Maurice Anthony Martinez, 44, was arrested Wednesday and placed on paid administrative leave.

Stewart said an anonymous complaint to the Department of Human Services led to an investigation. Stewart said Martinez was interviewed by police, but he would not discuss the details of the interview.

Stewart would not say whether the accusations involve any of the children living with Martinez. Oklahoma City police never disclose the names of victims of alleged sex crimes.

All six children were taken into state custody.

Martinez is the only adult living in his home, Stewart said. He said the 18-year veteran officer has been a foster parent and adoptive parent for 11 years and is a patrol officer assigned to the south side of Oklahoma City.

Stewart said Martinez will remain on leave pending the outcome of criminal and internal investigations.

Martinez was booked into the Oklahoma County jail and later released on \$80,000 bail, officials said. He has not been charged.

Records reveal details of police officer's sexual assault charges

LUBBOCK, TX (KCBD) - Jason Hignight, 32, resigned as a Lubbock police officer shortly before detectives arrested him Tuesday evening. Hignight is charged with two counts of sexual assault of a child and one count of indecency with a child.

"We police our own. And when something like this happens we handle it aggressively and that's why I'm here today. We're out in front of this," said Captain Greg Stevens, Lubbock Police Department.

According to the police reports, Hignight's two adopted daughters, ages 16 and 12, were interviewed by police about the allegations after the mother of the girls brought them to the police department.

According to an arrest warrant, Hignight's wife walked in him exposing himself with one of the victims. The 16-year-old victim told police that the sexual assaults have been going on for three years.

That same victim said in the warrant Hignight had been "feeling on her, they have had sex, and she has given him oral sex." She advised it occurred when Hignight was off of work on Tuesdays and Wednesdays.

In the warrant, the 16-year-old victim described one incident where "she had her head under a blanket and was giving him [Hignight] oral sex." She said a 12-year-old family member saw this incident. She told police it occurred repeatedly in many locations around Lubbock, including their current residence.

"You sit back and you think is there something we missed that we could have seen," said Stevens.

The 12-year-old victim told police in the warrant Hignight would usually touch her inappropriately when they were watching movies. She said her mother was not present when the sexual abuse happened.

"When something like this crops up from the criminal side and the administrated side, time is an essence when you begin investigating, because you have to get at it as quick as possible because you have victims you have to look after," said Stevens.

According to Hignight's Facebook page Hignight had an interest in foster care. In the picture from Facebook dated April 2009, Hignight commented that he was planning on adopting six children. LPD told us there were five children living in the home as of yesterday.

Hignight has been a Lubbock Police Officer since January 4, 2010 and police said he was still on a probationary status. The human resources section of the City of Lubbock's website says that an employee of the department has a probationary period of either 12 to 18 months starting on the first day of employment. His probationary period would of ended July 4, 2011.

LPD said they do an extensive background check on every incoming officer. "It's exhaustive, there's a polygraph exam. There's a lot of things in place. But the process in any profession, they're not fool proof," said Stevens.

Captain Greg Stevens said police learned of the accusations Tuesday afternoon around 2:30pm, and Hignight was arrested at about 9:30 PM that same day.

Stevens added that this is an ongoing investigation and no other details can be made available at this time.

Hignight is in jail on a \$200,000 bond.

We learned Wednesday that the two adopted daughters are with Hignight's wife who is not in contact with her husband.

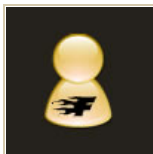

Winters would not say what evidence police have gathered, but he said Concepcion is being held in the Winnebago County Jail.

According to the Byron Police Department website, Concepcion joined the department in 2008.

Byron Police Chief Todd Murray said he does not have a comment on the arrest at this time.

Former police chief guilty of 15 charges in molestation case

McPHERSON -- After 13 hours of deliberations over the past two days, a McPherson County jury has found a former Inman **police chief guilty of 15 charges for molesting, inappropriately touching or soliciting three girls in 2009.**

Mike Akins Jr., 39, was found innocent of four charges, including allegations he molested a boy and battered the boy in 2009. Among the convictions, however, was a second misdemeanor battery charge involving the boy.

Akins is scheduled for sentencing Feb. 1, and Senior District Judge Ronald Innes has allowed him to remain free on \$250,000 until sentencing. Akins posted the bond shortly after his arrest last January.

He faces two life sentences without possibility of parole for 25 years, under Jessica's Law.

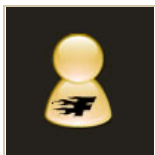

Morikawa has been placed on leave.

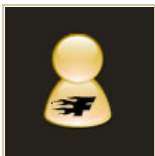

DoD officer charged with enticing teen for sex

A Department of Defense rookie police officer was arrested after he arranged to get off work to have sex with a 13-year-old boy, according to charging documents. Matthew K. McMullen, 26, was arrested after he arrived at the prearranged meeting site in D.C. with a loaded pistol in his vehicle.

McMullen, of Waldorf, was charged with enticing a minor to engage in sex. He faces a penalty of at least 10 years in prison if convicted. He remained behind bars Tuesday, and his first court appearance is scheduled from 2:30 p.m. Wednesday.

A Navy spokesman said McMullen has worked at the Patuxent River Naval Air Station in St. Mary's County since September.

According to charging documents, McMullen on Friday logged on to a Web site under the screen name "HKtop123," and sent a message to an undercover cop that read:

"I'm as perved as they come."

McMullen began having an online conversation with the undercover officer, who was posing as someone who was offering a teenage boy for sex. McMullen said he had sex with boys as young as 15 years old, court documents said.

McMullen said he wanted to meet with the boy that afternoon but he had to go to work.

McMullen then texted his supervisor, who gave him permission to begin his work four hours later than scheduled.

McMullen agreed to meet with the man at a fast-food restaurant in D.C., and engage in a brief sex act with the undercover officer to prove that neither of them was working as a law enforcement officer. Then they'd go to a nearby apartment where the 13-year-old boy was waiting.

McMullen was arrested by members of the child exploitation task force. Officers searched McMullen's car and found a loaded Glock 9 mm semiautomatic pistol in the trunk. McMullen said the gun was not his service weapon.

Trooper charged with sex assault

Attacks on teenage girl continued over 2 years, complaint alleges

A 48-year-old Wisconsin state patrolman has been charged in Green County Circuit Court with three felony counts of sexual assault of a child who was placed in his Town of Clarno home for foster care in November 2008, a criminal complaint says.

James M. Norquay was suspended without pay indefinitely, pending an independent administrative investigation of the allegations, State Patrol Capt. Charles Teasdale said. Norquay is a trooper with the patrol's Southwest Region.

The child was 15 years old at the time of the first assault, according to the criminal complaint filed by special prosecutor Dennis Krueger, an assistant attorney general. She is now 18.

The assaults continued until the child was removed from the home on Jan. 2 of this year, the complaint says.

Norquay is scheduled to make an initial appearance Monday on the charges in Green County Circuit Court, according to a news release from the Wisconsin Department of Justice. Each count carries a maximum penalty of 40 years' imprisonment and a fine of \$100,000.

The charges against Norquay resulted from an investigation by the Justice Department's Division of Criminal Investigation.

"Investigation and prosecution of cases involving those who prey on children are a high priority of the Department of Justice and we will continue to assist local law enforcement and prosecutors in child maltreatment investigations," Attorney General J.B. Van Hollen said in the release.

Officer charged with fondling girls during stop

MIAMI (AP) -- A Miami-Dade police officer has been charged with fondling two teenage girls during a traffic stop.

Police say 24-year-old Juan Carlos Rodriguez was charged Thursday with two counts of lewd and lascivious molestation. He was being held on \$150,000 bail.

An arrest warrant says Rodriguez pulled over a car in West Kendall on Jan. 11 and fondled the girls, who were passengers in the car, behind a CVS pharmacy.

Detectives found that Rodriguez had assaulted other young women in a similar manner in the same neighborhood.

Police say Rodriguez's searches of these young women were not done according to police protocol and served no legitimate purpose.

It wasn't immediately clear if Rodriguez had an attorney.

Policeman charged in sting operation

A Fort Valley police officer was arrested at a local residence last Wednesday afternoon and charged with enticing a child for indecent purposes following an undercover investigation by the Lumpkin County Sheriff's Office.

Brett Alan Crowe, 33, of Greensboro arrived in Lumpkin County with the alleged intent to have an illicit meeting with a minor. Instead he was greeted with LCSO investigators.

"He was charged and booked into the Lumpkin County Detention Center," said Sheriff Stacy Jarrard.

The Web-based investigation began the day before the arrest when Crowe reportedly began to chat online with someone who he assumed was a 14-year-old girl.

There was no such girl, said Jarrard. A meeting time and place was soon established and Crowe showed up in Dahlonega around 3:30 p.m. the next day.

The online conversation itself was reportedly enough for Crowe to be charged under the Computer or Electronic Pornography Child Exploitation Prevention Act.

"It's a felony," said Jarrard. "That's just from having a conversation with someone to solicit sex."

After the suspect was apprehended he reportedly informed officials that he is also a law enforcement officer in the middle Georgia town of Fort Valley.

He is now facing the additional charge of violation of an oath of an officer.

Major Lawrence Spurgeon of the Fort Valley Police Department said Crowe was a relatively new hire who started work at the agency in October. He is now on administrative leave without pay.

"We're conducting our own internal investigation," he said.

Spurgeon added that Crowe was able to make it through the interview process without drawing suspicions or raising any red flags.

"We are a certified police agency," he said. "We have a very stringent hiring policy. He had to pass a polygraph test and he had to pass a psychiatric evaluation."

Investigators: Paterson police officer arrested on child pornography charges

PATERSON -- Investigators arrested a five-year veteran city police officer on child pornography charges Thursday, culminating a three-month investigation, the Passaic County Sheriff's Department said.

Officer James R. Berthold, 39, of Paterson, was arrested at his home without incident at 11 a.m. The patrolman was arrested on possession of child pornography and distribution of child pornography, Passaic County Sheriff Richard Berdnik said in a statement.

"Possession and distribution of child pornography is a serious offense," Berdnik said. "The fact that this suspect is a sworn police officer makes this matter even more alarming and disturbing."

The three-month investigation began late last year when the Sussex County Prosecutor's Office received nine reports from the National Center for Missing and Exploited Children, which revealed complaints from America Online concerning the distribution of approximately 12 child pornography images, the sheriff's office said in a statement.

The prosecutor's office forwarded its findings to the Passaic County Sheriff's Office Internet Crime Task Force, which launched an investigation and found the 12 images were allegedly transmitted from Berthold's computer and e-mail address, the statement said.

Bill Maer, spokesman for the Passaic County Sheriff's Department, said Berthold was sent to the Passaic County jail on a \$75,000 bail set by Superior Court Judge Marilyn C. Clark. He was transferred to the Bergen County jail Thursday evening because of the nature of his job, Maer said.

He said none of the criminal allegations against Berthold are work related and additional criminal charges are pending.

Lt. Alex Popov, a Paterson police spokesman, said a department investigation is ongoing and Police Chief James Wittig and the internal affairs division cooperated with the Passaic County Sheriff's Department. Popov said Berthold is under suspension pending the outcome of the investigation.

The police department was surprised and shocked by the nature of the allegations against Berthold, Popov said. He said Berthold was assigned to the patrol division and was a good employee as far as he could tell.

The Passaic County Prosecutor's Office and the Paterson Police Department Internal Affairs Division assisted in the investigation. Berthold may face additional charges when the results of a forensic analysis are finished, Berdnik said.

PBA President Detective Steve Olimpio did not know if Berthold had an attorney.

"We're concerned about the allegations and the arrest," Olimpio said. "We hope they're not true. Everyone is innocent until proven guilty. It's serious stuff. These are issues that I don't think anyone wants to talk about." E-mail:

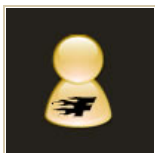

Ex-cop, scout leader from Fredericktown, Mo., gets life for sex crimes

ST. CHARLES . A former Fredericktown, Mo., police captain and Boy Scout leader was sentenced in St. Charles this morning to three consecutive terms of life in prison plus 22 years for sexual contact with two young boys.

Kenneth D. Tomlinson II, 43, once held the Fredericktown Police Department's top job. In November, he pleaded guilty on 16 counts of statutory sodomy, three counts of sexual exploitation of a minor and three counts of possession of child pornography. He admitted to having sexual contact with two boys in 2009, **beginning when they were 11 and 13 years old.**

Attorney General Chris Koster argued for the state at this morning's sentencing. He said Tomlinson's crimes had "pulled the pin on a grenade" that had yet to go off. The boys will deal with the abuse throughout their lives, he said.

Koster asked for two life sentences. **"Because the crime never ends, full retribution is appropriate," he said.**

Public Defender Susan DeGeorge asked for a total sentence of 20 years. She said that was five years longer than any of the sentences proposed by a sentencing assessment prepared by the state Department of Probation and Parole.

She said her client was sexually abused as a child and, as a psychologist testified, he suffers from major depressive disorder and post-traumatic stress disorder. **He also served as a police officer and firefighter for 14 years,** she said.

"Everyone wants to ignore all the good in people and just focus on the bad," DeGeorge said.

DeGeorge also read a statement from Tomlinson. In it, he apologized to the boys and their families and said he needed treatment.

"Yes, I am sick," the statement said. "I do need help, and I intend to get a lot of it."

As part of the state's evidence, Koster presented videos taken from Tomlinson's computer. Circuit Judge Ted House watched them on a laptop computer, sometimes turning away from the screen. Koster said Tomlinson shot one scene in the shower at a scout camp.

House sentenced Tomlinson to more time than Koster asked for -- a total of three consecutive life sentences plus two more consecutive terms of seven and 15 years.

The boys' parents testified that the effects of the abuse have been devastating to their whole family. The boys are angry and depressed, and their grades have suffered, they said.

After the hearing, the boys' father said he was glad Tomlinson would not leave prison alive. "I'm glad he got what he deserved," he said.

Former school resource officer at Searcy, Ark., pleads guilty to sexual assault of 16-year-old

Police said Riley was arrested by state police on Feb. 23, 2010, **after he crawled through a window into the bedroom of the girl**, who was not present.
