N. Brookfield cop charged with rape

Sex alleged with 15-year-old

EAST BROOKFIELD — A North Brookfield police officer who allegedly forced a 15-year-old family friend to perform oral sex on him is free on \$1,000 bail after his arraignment yesterday in Western Worcester District Court on three charges related to the Oct. 13 incident.

Adam J. Kachadoorian, 42, of North Brookfield, was arrested by state police Saturday at his home, according to court documents.

The girl and her family told investigators he'd also sent a photo of male genitalia to her cellphone, texted her to ask if she was going to tell her parents and when they confronted him, admitted to the oral sex, saying it was consensual.

Court documents indicate Officer Kachadoorian also told his wife about the incident, and she shared that information with the girl's family when they met with her. N. Brookfield cop charged with rape 4/10/12 3:02 PM

Police found the photograph and text messages on the teenager's cellphone and took other evidence from her home in Leicester, where the alleged incident took place, a court report says. The girl's father told state police

where the alleged incident took place, a court report says. The girl's father told state police detectives he had just learned of the incident on Saturday, and as he was confronting her about it, Officer Kachadoorian sent her a text message asking if she planned to tell her parents what had happened.

Officer Kachadoorian was booked at the state police barracks in Brookfield and was arraigned yesterday on charges of distributing obscene matter, rape of a child and indecent assault and battery on a person more than 14 years old.

Officer Kachadoorian graduated from the Massachusetts Criminal Justice Training Council Academy in 2002. He worked as a dispatcher for the Hubbardston Police Department and later as a part-time police officer in Leicester. He joined the North Brookfield force as a full-time patrolman in 2004.


North Brookfield Selectman Jason M. Petraitis said Officer Kachadoorian is on paid administrative leave pending the outcome of the case. He said board members would not comment further because the matter is before the court.

According to the 2010 annual town report, Officer Kachadoorian was paid \$47,663 in calendar year 2010. That figure includes payment for traffic details. As part of his recent training, in 2010 he attended a program about child abuse.

Officer Kachadoorian is due back in Western Worcester District Court in East Brookfield on Dec. 13 for a pretrial hearing.
