Cop offered favors for oral sex from teen prostitute, detectives say

Investigators say a Haines City police officer repeatedly received oral sex from a teenage prostitute — while in uniform — and agreed to give her pimp "special favors" in return.

The officer, 25-year-old Demetrius Lamar Condry was arrested on Thursday. He resigned from the police department upon his arrest, according to the Polk County Sheriff's Office.

Sheriff's detectives worked with Winter Haven and Haines City police to investigate Condry and suspected pimp Paul Rosoan Aaron, himself a Polk County school bus attendant.

Through a company he called "Genuine Quality Entertainment" and ran out of a home on 7th Street in Haines City, investigators say Aaron, 27, typically charged about \$60 for sex with teens.

Condry, detectives say, was a frequent customer of GQE. And investigators say he paid not with cash, but with the promise of favors, acting in his role as a Haines City officer.

Investigators say the two victims were 14 and 16 years old when the prostution began. They told detectives that Aaron had also forced them to have sex with him numerous times.

Condry was charged with sexual battery by a law enforcement officer, lewd battery and official misconduct, all felonies. It was not clear if Aaron ever made use of the "favors" discussed.

Aaron was charged with bribery of a law enforcement officer, procuring a minor under 18 years-of-age for prostitution and sex trafficking, also felonies. Reports show he cooperated with investigators.

According to arrest reports, detectives recorded Condry asking Aaron for sex with one of the teens "on the house." The Sheriff's Office says its investigation is ongoing.
