HURON, SD - A former Huron police officer will spend 30 days in jail for sending sexually explicit text messages and videos to a 15-year-old girl.

Prosecutor Dawn Elshere says 38-year-old Tony Beerman pleaded guilty Wednesday to a misdemeanor charge of disseminating harmful material to a minor.

Elshere said Beerman was fined \$500 and sentenced to 120 days in jail, with 90 days suspended.
