## Ex-New York Police Officer Sentenced To Over 21 Years in Prison

### *Souther District, New York*

*Ex-New York Police Officer and martial arts instructor, Trent Young, 42, was sentenced February 28, 2011 to over 21 years in prison for transporting three minors across state lines for the purpose of engaging in illegal sexual activity with them. Young was sentenced Monday at the prison ward of the Westchester Medical Center, at his bed side, where he is currently being treated for a terminal illness. Reports don't indicate exactly what kind of illness Young is being treated for but most say that it is cancerous.*

*Along side being a New York City police officer, Young operated a martial arts studio in West Milford, New Jersey called, "The Iron Tiger Martial Arts" which Young founded in the spring of 2006.*

*Young plead guilty to the charges in the indictment on July 2009 that stated :*

*In April of 2003 he drove a 14 year old girl from her home in Brooklyn, New York and traveled through New Jersey to his home in Middletown where he later had sexual intercourse with her.*

*Between October or November of 2006 he brought a different 14 year old girl from Middletown, New York to his dojo in West Milford where he later had sexual intercourse with her also.*

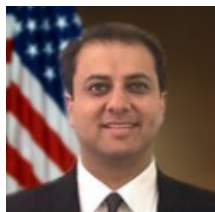
*Between November or December of 2006 he brought a different girl who was 16 years old at the time to his dojo and had sexual intercourse with her as well.*

*In a report announced by U.S. Attorney Preet Bharara, indicated that while pleading guilty, Young admitted that he transported each of the three minors across state lines for the purposes of engaging in sexual activity and that, after transporting the minors he engaged in sexual intercourse with each of them. Young also admitted to having supervisory control over each of them.*

*After sentencing Young to 262 months in federal prison, United States District Judge Kenneth M. Karas mentioned that the "extremely high" sentence was appropriate in light of what young did to the girls he chose as victims, and added that the "magnitude of the conduct here outweighs the medical issues" that Young is dealing with.*

*United States Attorney, Preet Bharara commended the work and assistance of the N.Y F.B.I, the Middletown P.D, the Orange County District Attorney's Office, the Rockland County Sheriffs Office, the West Milford, NJ P.D, and the Passaic County Prosecutors Office.*

*O.K Young is a ex police officer that is imprisoned for raping three young girls. For Young's sake he better hope and pray that he stays terminal while he's serving his sentence, because from what I've seen and heard about prison life, convicts don't cops,crooked or not, and that they also have a special disliking for rapist, especially child rapist. It looks like life as Young knows it is pretty much over. Justice will served*
