# Former Catoosa County deputy indicted on charges of sexual abuse and distributing porn



A former Catoosa County sheriff's office deputy has been indicted on 13 sexual child abuserelated charges involving one girl, records show.

Stephen Crossen, a 5 1/2-year department employee, was fired on Feb. 29 for a policy violation, Sheriff Phil Summers said at the time.

The county grand jury indicted Crossen on six counts of sexual exploitation of children, one count of sodomy, five counts of distributing pornography to a minor, and one count of interference with custody on Wednesday.



He turned himself in a little after 1 p.m. today.
