New Legislature Passed To Protect Child Victims of Human Trafficking

New legislature was passed this week in the Senate to protect children who are victims of child pornography and sex trafficking. The bill called the "Child Protection Act of 2012" was sponsored by Texas Senator John Cornyn. It passed the Senate late on November 27, and is waiting to be signed by President Obama to become law.

The bill had previously passed the House of Representative and was sponsored in Congress by Sen. Cornyn and Senator Blumenthal (D-Conn.). The bill was part of the Domestic Minor Sex Trafficking Deterrence and Victims Support Act of 2011. Introduced by Sens. Cornyn and Ron Wyden (D-Ore.). The bill is awaiting presidential approval to become law.

"We need to provide law enforcement with every tool they need to crack down on the most vile criminals – child sex predators and traffickers – and protect the innocent young people who fall victim to these heinous crimes. This is an issue we can all agree on, and I'm pleased Congress has passed this important measure in a bipartisan fashion," Sen. Cornyn

The bill will provide increased sentences for people convicted of possession of child pornography depicting a minor under the age of 12-years-old. Currently, there is a maximum sentence of 10 years but if the bill becomes law it will increase to 20 years.

It will require federal judges to issue a protective order for child witnesses. The bill will also make it easier for U.S. Marshalls to acquire evidence and apprehend fugitive sex offenders.

The legislature will also reauthorizes funds for the Internet Crimes Against Children Task Forces, which train officials on how to deal with cases of child sexual abuse.
